

Message from HGCAA President



March 2022

1 March – Mardi Gras known as Shrove Tuesday or Fat Tuesday falls annually on the day before Ash Wednesday (*start of Lent*). The word "Mardi Gras" means "Fat Tuesday" in the French language.

2 March – Ash Wednesday is celebrated on Wednesday seven weeks before Easter and the day after Mardi Gras also referred to as Fat Tuesday. This is a Christian observance which represents the first day of Lent and the starting of approximately 6 weeks of fasting and penance.

4 March – Employee Appreciation Day is held on the first Friday in March allowing management to show thanks and reward their workers for their hard work throughout the year.

13 March – Daylight Saving Time starts on the second Sunday of March for the United States. Clocks are turned forward one hour from 2 am to 3 am.

20 March – First Day of Spring also known as the March equinox or vernal equinox is when the sun shines directly on the celestial equator passing from south to north and the length of day and night are almost the same.

March is shaping up to be just as busy as February. The 3G/4G Sunset is pressing full steam ahead. Most of us were expecting all the 3G and 4G M2M cellular devices to go dark at midnight on 2/22/2022 and when they didn't, we thought we might have dodged a bullet. No such luck. The Telguard and Napco radios do have roaming capabilities and they struck a last-minute deal with T-Mobile to take that traffic. That said it sounds like most of the other manufacturers may not have that same roaming capability.

For those that haven't failed yet the Sprint's 3G CDMA network is next to drop out by March 31, 2022. Sprint's 4G LTE network will be next to drop by June 30, 2022. T-Mobile will shut down their 3G network by July 1, 2022. Last but not least Verizon is shutting down what's left of their 3G CDMA network by December 31, 2022. The bottom line is we need to remain steadfast in getting all those radios upgraded.
